SUBJECT: **ELECTION OF DELEGATES TO THE MRTA ASSEMBLY OF DELEGATES**

It is time to elect delegates from your unit to attend the MRTA Assembly of Delegates which will be held Tuesday, September 12, 2017 at the Capital Plaza Hotel, Jefferson City, Missouri.

SELECTION: Only members whose State and local Unit dues are paid are qualified to be a delegate. Delegates must also register to attend the Annual Meeting

NUMBER: Each local unit is entitled to one delegate if it has from 1 to 100 qualified unit members of the MRTA. Qualified members are active members whose State and local Unit dues are paid.

1 to 100 qualified members = 1 delegate
101 to 200 qualified members = 2 delegates
201 to 300 qualified members = 3 delegates
301 to 400 qualified members = 4 delegates, and so on

ALTERNATE: Elect an alternate at the meeting in case your delegate cannot attend. Alternates may sit in the visitor's section.

REPORT: Please complete the enclosed Delegate Registration Form to report your elected delegates and alternates and mail to: MRTA, 3030 DuPont Circle, Jefferson City, MO 65109. Deadline: Must be received on or before August 15, 2017.

IMPORTANCE: This is an effort to make the MRTA truly representative of all the state. Local units are an important part of MRTA. The MRTA ByLaws [Article XIV, Section 3, Part (b)] state we must have this form on or before August 15, 2017 for Delegates to be able to vote at the 2017 Annual Meeting.

LODGING: This is NOT to be considered as the Delegates' room reservation or meeting registration. One night's lodging will be provided per Unit. If your Unit needs an additional room it will be at the expense of your Unit at \$93.63. Lodging and meeting registration information will be sent at a later date.

EXPENSES: Since MRTA does not have funds to defray the delegate expense, we are asking local units to provide expenses for the delegates. Thank you for your cooperation.
