DEADLINES FOR PUBLICATIONS

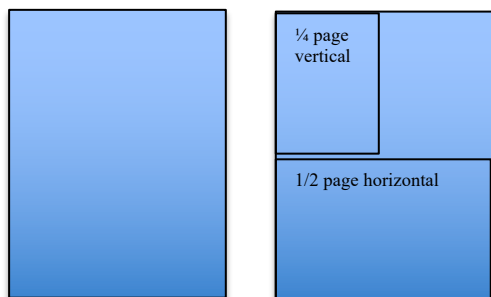
The deadline for advertising in the May publication is May 1 each year. The publication will be distributed to all members of MRTA in June.
